Responsibility - Scott Borowiak Tours or its agents act only as agent for owners and operators to transportation, accommodations, services, and facilities and its/their responsibility is limited to that of an agent. Increases due to adjustment of airfare, cost of land arrangements or international currency fluctuations will be passed on to the passenger in all cases provided said increases are advised the passenger prior to commencement of the tour. Changes in the itinerary include air, hotel or services, are not likely, however, we reserve the right to make such changes as may be necessary for the comfort and safety of passengers.

Cancellation Policy:

- If notice of cancellation is received 70 or more days before departure, the cancellation fee is \$50 per person.
- If notice of cancellation is received 45-69 days or more before departure the cancellation fee is \$100 per person.
- If notice of cancellation is received 8-44 days or fewer before departure the cancellation fee is \$650 per person.
- If notice of cancellation is received 7 days or fewer before departure the cancellation fee is \$1,000 per person.
